## HEARING TRANSCRIPT

HO Hailey: This is the time and the place of the hearing in the matter of the driving privileges of Robbie Dale Wilson, customer number date of

birth This hearing is being conducted on June the 2<sup>nd</sup>, 2015 at the Division of Motor Vehicle Offices located at in Asheboro, North Carolina which is Randolph County. Uh I am Hearing Officer Hailey, the Administrative Hearing Officer assigned to hear this case.

Now pursuant to Chapter 20 of the North Carolina General Statutes the

Now pursuant to Chapter 20 of the North Carolina General Statutes this hearing was scheduled at the request of petitioner after being notified that the Division was in receipt of an Ignition Interlock Report from the ignition interlock service provider certivi-, certified by the Commissioner of the Division of Motor Vehicles. Uh the Ignition Interlock Report claims that the petitioner operated a vehicle when the ignition interlock system indicated an alcohol concentration in violation of the restriction placed upon him by the North Carolina General Statutes §20-17.8 (b3). The Non-compliance Report, Monitor Report, and Logger are part of the file that has been prepared for my consideration and has been marked as Division Exhibit 1. The Non-compliance Certification Report has been marked as Division Exhibit 2 and the Motor Vehicle Record for the petitioner has been marked as Division Exhibit 3.

Now let the record show that present at the hearing we have petitioner um Robie (sic) Robbie Dale Wilson uh he does not have counsel. And Mr. Wilson would also like to present a witness uh and Mr. Wilson

what will your witness' name, what is your witness' name?

Robbie Dale Wilson: Stacey Marie Wilson.

HO Hailey: Uh and uh he also plans to present a witness uh Stacey Marie Wilson.

Uh now I remind cou-, uh, so at this time Mr. Wilson I'm going to swear you in. If you can stand up, put your left hand on the Bible, raise your right. Do you solemnly swear or affirm that any testimony that you provide today will be the truth, the whole truth and nothing but the

truth?

Robbie Dale Wilson: So help me God.

HO Hailey: You do?

Robbie Dale Wilson: I do.

HO Hailey: Alright. Thank you sir. Alright uh and in essence Mr. Wilson we're

going to have um three different hearings because there are three different logger reports that have been received so in order for us to not keep bringing you back you know interrupting your schedule, we're going to uh, there will be three different uh decisions that are rendered

based on these three different logger reports.

Robbie Dale Wilson: Correct.

HO Hailey: Okay. And can you confirm your name and address for the record

please?

Robbie Dale Wilson: Robbie Dale Wilson. Address

HO Hailey: Okay. And Mr. Wilson uh we're going to talk first about the Monitech

Non-compliance Report dated on April 25<sup>th</sup>, 2014. Uh in which it shows that your required retest uh was a high-fail. Uh and this was on April 24<sup>th</sup>, 2014 at 9:18 a.m. It was a high-fail at a .01 uh so we're going to go, there were four incidents with regard to this April 25<sup>th</sup>, 2014 Non-compliance Report. And the, can you explain why on uh April 24<sup>th</sup>, 2014 at 9:18 a.m. uh machine registered a blood alcohol

concentration level of .01?

Robbie Dale Wilson: And that would be I was on my way to Elizabeth City and it actually

locked me out. That machine has a mind of its own especially if my diabetes is out of control or high so it registered that the acetone in my breath. I did have a highway patrolman to pull up behind me who I requested uh him give me a blood alcohol test which registered a 0.0.

HO Hailey: Okay. Now...

Robbie Dale Wilson: Which...

HO Hailey: ...okay what is the date on this cause I don't see a date on this.

Robbie Dale Wilson: Yeah I was trying to find the date. The date is that morning.

HO Hailey: Uh okay I see

Robbie Dale Wilson: That's my birthday.

HO Hailey: Birthday. Yeah I don't see a date in which this...

Robbie Dale Wilson: Uh he might have forgot to put it on there.

HO Hailey: Okay it's 4/24/2014.

Robbie Dale Wilson: I know it's the date registered on that one.

HO Hailey: Uh at, at 9:46 a.m. okay so um this report from Trooper S. D. Vaughn of

the North Carolina State Highway Patrol in Randolph County states that I stopped to check uh out this vehicle on Thursday 4/24/2014 at approximately 9:46 a.m. Mr. Wilson said his Monitech breath analyzer had locked him out from driving his vehicle for 45 minutes. I checked

Mr. Wilson on my AlcoSensor type 4 series 026048 at 9:49 a.m. and

registered a .00. Now at 9:49 a.m. that was hmm let me see uh...

Robbie Dale Wilson: It was probably about 20 minutes after.

HO Hailey: It uh actually it was more like 30 minutes afterwards.

Robbie Dale Wilson: But your blood alcohol is not going to change that much. Not in the

time, I'm just saying I'm...

HO Hailey: That's your argument sir?

Robbie Dale Wilson: No, I'm just saying that those machines are not accurate and that is

according to the company themselves.

HO Hailey: Okay do...

Robbie Dale Wilson: They say they can't...

HO Hailey: ...do you have information with regards to that?

Robbie Dale Wilson: No because they will not give it to me. They're not going to admit to

their machines.

HO Hailey: Okay. Alright.

Robbie Dale Wilson: I mean but I do know for a fact you can take a swallow of anything go

out there and blow in the machine and you will register.

HO Hailey: Okay.

Robbie Dale Wilson: Also I had, I do have where diabetes affects the machines, effects what

comes out of your breath.

HO Hailey: Okay.

Robbie Dale Wilson: But the machine doesn't get you know like if a bre-, if it sees anything

that machines going to pick it up. And .01 if somebody's drinking which I don't drink not any, any, I mean I've quit for the past 5 years

and if you're drinking you're going to be a lot higher than .01.

HO Hailey: No nec-, not necessarily sir.

Robbie Dale Wilson: If you take...

HO Hailey: We are trained, we are trained on how to read these loggers...

Robbie Dale Wilson: I...

HO Hailey: ...okay so we know exactly what is true blood alcohol and what is not

true blood alcohol. And a .01 may under certain-circumstances violate your conditional restoration if you are, if you have a restriction of .00

true blood alcohol...

Robbie Dale Wilson: Uh huh.

HO Hailey: ....so we're trained on how to analyze true bl-, blood alcohol...

Robbie Dale Wilson: Uh huh.

HO Hailey: ...based on the loggers, okay.

Robbie Dale Wilson:

But the loggers not true blood alcohol. In order to get true blood alcohol you have to have an NIR spectrometer. And that's according to four doctors whom I r-, who I have as clients. That breathing...

HO Hailey:

Who is...

Robbie Dale Wilson:

...is like uh after effects. All its doing is picking up you know pa-, particular that are in your breathing.

HO Hailey:

So if I understand correctly you're saying that the uh oh that the uh the high-fail of .01 on 4/24/14 was due to your diabetic condition?

Robbie Dale Wilson:

It is due to diabetes or possibly I didn't rinse out good enough after I ate a cracker cause was on my way to Elizabeth City...

HO Hailey:

Hmm.

Robbie Dale Wilson:

...so I ate a pack of crackers for breakfast. I believe I would like to stop this hearing and get an attorney to represent me at this point.

HO Hailey:

Um.

Robbie Dale Wilson:

I request counsel.

HO Hailey:

Okay. Um I need to call my supervisor and see if that is possible because typically we need 48 uh 24 hours notice um...

Robbie Dale Wilson:

Okay it's just your being a little more difficult than the lady in Hickory that I dealt with, the last Examiner. See I've had this done already and she...

HO Hailey:

I, I understand sir.

Robbie Dale Wilson:

...??? And I mean she, she agrees, she knows that. I mean she's been doing it a lot of years.

HO Hailey:

I understand.

Robbie Dale Wilson:

Robbie Dale Wilson:

And she knows. Okay I'm just trying, I'm trying to make my case.

HO Hailey:

I understand sir so um so because you think that I'm going to rule against you, you want an attorney. If that, that's the understanding?

Yes.

HO Hailey:

Because you think I'm going to rule against you...

Robbie Dale Wilson:

That's just what I'm, yeah.

HO Hailey:

...want an attorney?

Robbie Dale Wilson:

That is correct.

HO Hailey:

Okay. Well um...

Robbie Dale Wilson:

I mean it doesn't...

HO Hailey:

...what we're going to do is go forward with the hearing.

Robbie Dale Wilson:

Okay.

HO Hailey: Okay. And I am then going to consult with my supervisor and if he tells

me to go forward with my decision I will go forward with my decision. If he tells me that you to allow you to have an attorney then I will um uh then I will reschedule, okay.

Robbie Dale Wilson: Okay.

HO Hailey: Alright. Does that make sense?

Robbie Dale Wilson: Uh hmm.

HO Hailey: I think that's an excellent compromise okay and that way I, because

you're taking the space of somebody else who could have been here you

know this morning. Okay. Okay.

Robbie Dale Wilson: Can you also look at that first one and see how many minutes it was

before, like how many minutes went by that I blew and started the car and then I blew again and it was saying .01? What the time lapse was?

HO Hailey: Okay so uh at, at 9:01 the BAC reading was a .00, at 9:10 on a running

retest the BAC reading was a .01.

Robbie Dale Wilson: So 10 minutes.

HO Hailey: Uh hmm. Yes sir.

Robbie Dale Wilson: Alcohol doesn't process that fast.

HO Hailey: Okay.

Robbie Dale Wilson: It was ??? those things.

HO Hailey: Uh at 9:12 the BAC reading was still a .01...

Robbie Dale Wilson: Uh hmm.

HO Hailey: ...and 9:18 uh the BAC reading was still a .01 and at 10:03 the BAC

reading was a .00. Uh a running retest was ignored at 4:04. At 1:38

p.m....

Robbie Dale Wilson: Yeah that was my...

HO Hailey: So...

Robbie Dale Wilson: ...I, I totally admit that. I ran into one of my clients. I left the vehicle

running in front of their place of business cause I was just running in to get a piece of equipment and I got, I hung up by the owner and I thought I had enough time which I didn't so I had to restart. So that was just a

bad mistake on my part for not cutting the machine off.

HO Hailey: And what about the, so e-, o-, and as you know with the, with the uh

ACR hearings um alcohol concentration restriction hearings, what we're really focused on is the rolling retest so at 9:11 a.m. the rolling retest was still a .01. Okay but it's your testimony that it was due to your diabetic condition and the fact that you had eaten crackers and you did

not rinse?

Robbie Dale Wilson: Well enough.

HO Hailey: Uh hmm.

Robbie Dale Wilson: I did rinse but not well enough obviously.

HO Hailey: Okay.

Robbie Dale Wilson: 'Cause I've had several .01 readings but some were with the previous

machine. They did swap out the machine for me and ever since then it's been pretty good. It's been much better and they said that can happen too. They said they've got some machines that read differently even though they're all calibrated the same. But it has done a lot better since. So I try not to get rid of the machine I got now. The ??? rolling retest

uh on 1/11/2014, 1/11/2015.

HO Hailey: And if I understand your running retest was ignored.

Robbie Dale Wilson: Running retest ???

HO Hailey: On 4 uh let me see here.

Robbie Dale Wilson: It was just a few months ago.

HO Hailey: 4, 4, 4. Nope this was the same non-compliance report which is saying

that on April 4th, 2014 at 1:38 p.m. the uh and you're stating that it was

ignored because you were talking to a client...

Robbie Dale Wilson: I, I went into a client's office and left the vehicle running in front of the

office.

HO Hailey: Okay. And why did you leave the vehicle running?

Robbie Dale Wilson: Because I was just running in to actually get a part, a component to pull

out and it shouldn't have took me more than two minutes...

HO Hailey: Uh hmm.

Robbie Dale Wilson: ...so I mean I didn't want to have to restart the machine and redo

everything just because I was just running in but of course my luck ??? and wants to chat and that's when I should have run out there and just cut the vehicle off but I thought I had enough time and I didn't so like I said that was my mistake and my bad. Wasn't because I meant to ignore it. And I have since started to shut the vehicle off no matter

what. Here's BAC ??? .01.

HO Hailey: Okay is there anything else that you'd like to state...

Robbie Dale Wilson: Uh...

HO Hailey:

...about the non-compliance report dated on April 25<sup>th</sup>, 2014?

Robbie Dale Wilson: The uh April 25<sup>th</sup>? I've got a April 24<sup>th</sup>.

HO Hailey: April 25<sup>th</sup> is the n-, the date of the non-compliance report.

Robbie Dale Wilson: Oh the next day, the following day, okay yeah, okay that's right.

HO Hailey: No, the non-compliance report is actually dated April 25<sup>th</sup>, 2014.

Robbie Dale Wilson: Is that the one with the morning BAC?

to that the one with the morning Bire

HO Hailey: Yes.

Robbie Dale Wilson: Okay. 'Cause I'm showing that was incurred on the 24<sup>th</sup>.

HO Hailey: Okay the event occurred on the 24<sup>th</sup>.

Robbie Dale Wilson: Okay, okay.

HO Hailey: The non-compliance report which is how we index these is by report...

Robbie Dale Wilson: Uh huh.

HO Hailey: The report...

Robbie Dale Wilson: Oh okay the report...

HO Hailey: ...is dated April...

Robbie Dale Wilson: ...I understand.

HO Hailey: ...25<sup>th</sup>, 2014.

Robbie Dale Wilson: I gotcha now. So it's my, my bad. I'm j-, I, I'm trying to follow and I

was getting lost there.

HO Hailey: Yes sir. Okay so now we're going to talk about the non-compliance

report dated May 9<sup>th</sup>, 2014. And uh so the rolling retest uh on let me see so these are still, this is still talking about, these reports are still talking about April 24<sup>th</sup>, 2014 at um and April 4<sup>th</sup>, 2014. We've already talked about that and so this is also these uh non-compliance events are also located on the non-compliance report of May 9<sup>th</sup>, 2014 but since we've already talked about these events um we're not going to talk

about those again cause they're the same dates okay.

Robbie Dale Wilson: Okay.

HO Hailey: Now uh we will go to the non-compliance report of July 14, 2014 and it

says a rolling retest, high-fail rate of .01 and this was on June s-, 7th

2014 at 4:53 p.m.

Robbie Dale Wilson: And was there a lockout or was it several .01s in a row or, or was it just

one and then I blew again and it was 00?

HO Hailey: It was a rolling retest BAC of .01 so at 4:44 there was a BAC of .00. At

4:53 a BAC of .01 w-, and that was on a rolling retest.

Robbie Dale Wilson: So I crank the car, nothing was there, few minutes later all the sudden it

shows up.

HO Hailey: And then um at 4:53 it's a BAC of .01 and at 4:54 there's a BAC of .06.

Robbie Dale Wilson: .06?

HO Hailey: Yes sir.

Robbie Dale Wilson: Now that ones that would've to be, that wasn't drinking. I guarantee,

promise you that.

HO Hailey: Uh hmm. So what was it?

Robbie Dale Wilson: That had to have been a sugar one or uh contamination.

......

HO Hailey: Okay.

Robbie Dale Wilson: I don't never remember seeing one .06.

HO Hailey: Okay.

Robbie Dale Wilson: What happened shortly thereafter, I'm just curious what?

Okay in um and it is arrival test high-fail so that was uh arrival test uh HO Hailey:

high-fail.

Robbie Dale Wilson: Arrival test, now I don't have that one in front of me. I mean I've got

tons of .01s but I've never seen a .06.

HO Hailey: Okay I'll show it to you and I will make you a copy of that.

Robbie Dale Wilson: Okay, yes please cause uh I need to know what I put down at the uh

Monitech monitoring sight as to the reason cause I don't have it with

me.

HO Hailey: So you don't remember about this incident sir?

Robbie Dale Wilson: I remember a .01 and I remember that I'd, my sugars were really out of

whack at that point in time. I mean there for about 4 or 5 months my

alc was 9 and 10.

Okay. Now Monitech had submitted to, Monitech submitted to uh the HO Hailey:

Division that you did not present a client response form for this one.

Robbie Dale Wilson: Now why would not respond to it? I always responded to them ???

So this was the event date was June 7<sup>th</sup>, 2014... HO Hailey:

Robbie Dale Wilson: So last year?

...at 4:53 p.m. and it was a rolling retest high-fail of .01. Then you HO Hailey:

> ignored the arrival test and that was uh no that's a different date. Okay. So on the same date like I said it was a .01 at 4:53 p.m. um and that was

a running test and then at 4:54 p.m. there was a BAC of .06.

Robbie Dale Wilson: And that was an arrival test?

Arrival test high-fail. So I'll let you review these. HO Hailey:

Robbie Dale Wilson: Okay. Please cause that one does not ring a bell.

Okay. And if you can place your documents, yeah right there so we HO Hailey:

know, don't get them confused.

Robbie Dale Wilson: Get 'em confused, yeah that could be a mess then. I want to know what

> occurred after 'cause I remember one day and I had to pull off the side of the road and turn the ignition off. And I was over in Winston well Kernersville actually. And that would've been, that was right around June but I need to know what happened after this arrival test 'cause see there's nothing after it. I need to know if I cranked the vehicle right

back up.

Sir that's the information that we have. HO Hailey:

Robbie Dale Wilson: Yeah I see that but that's cutting it off. I mean that's like they don't

show you what happens afterwards. That's like saying you know

somebody you know broke into your house but you don't know who,

what all they took, you know.

HO Hailey: Uh hmm.

Robbie Dale Wilson: So I need to know...

HO Hailey: But breaking into the house is the, is the offense.

Robbie Dale Wilson: Crime, offense. Right.

HO Hailey: Uh hmm.

Robbie Dale Wilson: But I need to know what happened after this because if I start say for

instance say three minutes later I started it back with a .00 you know it can't go from .06 down to 00 in two to three minutes. You see what I'm

saying?

HO Hailey: I do. I, I understand.

Robbie Dale Wilson: Yeah.

HO Hailey: So sir um do you have any explanation for this?

Robbie Dale Wilson: The only explanation I've got I know the .01 I was riding down the road

I was near um uh Union Crossroad. I blew and alarmed it warned and then I got to exit at Highway 66 and I remember it locked me out. But I should've wrote something down on the paper. And I don't understand why I didn't since the let's see ???. You don't have the correct paperwork. The date on here is 7/14/2014. If they would have of, that would have been a lockout. That would have been a warning. The

machine wouldn't of, I would've had to go within three days.

HO Hailey: What, what are you looking at?

Robbie Dale Wilson: Where I had to sign.

HO Hailey: Uh hmm.

Robbie Dale Wilson: Okay I would've had to go within three days to get that warning cleared

out or it would've locked me out permanently.

HO Hailey: Uh hmm.

Robbie Dale Wilson: So they didn't send you over the correct date.

HO Hailey: Uh hmm.

Robbie Dale Wilson: Cause three days after that that's where I would need, where I would

have signed that you know put down what had happened.

HO Hailey: Uh hmm. Okay. Okay.

Robbie Dale Wilson: That's the regular Monitech monitoring appointment.

HO Hailey: Uh hmm.

Robbie Dale Wilson: But the one where it goes up that high or even a .01 it requires me to go

in within three days cause the machine will lock out.

HO Hailey: Okay.

Robbie Dale Wilson: And that's where my notes get ??? mine. Non-compliance.

HO Hailey: Okay then it's my understanding that these report, that you go in for a

download every...

Robbie Dale Wilson: Every uh two months. Uh hmm.

HO Hailey: ...two months, right. Okay.

Robbie Dale Wilson: But if you have a like a high value if you're set at 00 and you go to .01

or whatever you have to go in, it will lock out within...

HO Hailey: Uh hmm.

Robbie Dale Wilson: ...three days. It starts you know it gives you a warning every time you

go get in the vehicle...

HO Hailey: Uh hmm.

Robbie Dale Wilson: ...you have three days to you know contact them to schedule a service

appointment.

HO Hailey: Uh hmm.

Robbie Dale Wilson: Which costs me every time I have to do that.

HO Hailey: Uh hmm.

Robbie Dale Wilson: But that's where they you know they ask you to fill out some papers.

HO Hailey: Uh hmm. So do you uh do you have a non-compliance report in your

files. You stated that my report was incorrect.

Robbie Dale Wilson: I would have to get that from Monitech, the date that that, I would have

to go from that date did you see what I'm saying? And because what you've got is just a regular monthly, every two month report there. You

don't have the date where I actually went in...

HO Hailey: Mm.

Robbie Dale Wilson: ...to have that cleared.

HO Hailey: Okay.

Robbie Dale Wilson: See like right here...

HO Hailey: Uh hmm.

Robbie Dale Wilson: ...for instance on 2/21 which was not a regular scheduled appointment,

see where I had to put in a client response.

HO Hailey: Wait a minute, I, I'm very familiar with how...

Robbie Dale Wilson: ??? I'm sure you are...

HO Hailey: ...all of this.

Robbie Dale Wilson: ...I'm just it.

HO Hailey: Yeah but so uh and let me ask you this, do you have a doctor's note uh

that uh states that you are a diabetic?

Robbie Dale Wilson: No, but I can get one faxed over right now.

HO Hailey: Okay.

Robbie Dale Wilson: With an actual ??? I'd be glad to. Do you mind if I make a call to my

family doctor real quick?

HO Hailey: Um it oh you can do that after the hearing, okay I will take that

information after the hearing.

Robbie Dale Wilson: Okay.

HO Hailey: Is there anything else that you wanted to, s-, to mention about uh the

non-compliance report dated July 14, 2014?

Robbie Dale Wilson: Nnn-, only that I need to get the full information.

HO Hailey: Okay.

Robbie Dale Wilson:

Robbie Dale Wilson:

Because all the information is not there as far as what I put down for the reason. I'm 99.9% certain it was about diabetic reasons or I'd just eaten and didn't even rinse, that's possible. Cause at that time that was the

first year I'd actually had the machine and I was really learning the machine but we're talking about a year ago. Since then I've done you

know ??? got used to it ???

HO Hailey: So if I, if I understand your testimony correctly you're saying that we need your response in order to make a decision? You're saying...

I need to know what the response is, I need to know what I, what was going on at that point. I'm 90% sure it was a diabetic...

HO Hailey: Okay.

Robbie Dale Wilson: ...reason.

Okay now you, you do realize that the Division feels that this is, this is HO Hailey:

enough information for us to make a decision? You do realize that?

Robbie Dale Wilson: No I don't.

HO Hailey: Okay. Alright. So I'm, I'm trying to determine what your position is. What is your position with regard to the report, the Monitech Noncompliance Report dated July 14, 2014 where it says that there was a

rolling retest high-fail uh on June 7<sup>th</sup>, 2014 at 4:53 p.m. with a BAC reading of .01 and an arrival test of .06 at 4:54 p.m. and so your position

is...

Robbie Dale Wilson: There was no alcohol. Cause like I said I don't drink.

Okay. Anything else sir? HO Hailey:

Robbie Dale Wilson: Uh uh.

Okay. And um so at this point we're going to bring your wife in casue HO Hailey:

she wanted, you wanted to present her as a witness.

Robbie Dale Wilson: That is correct.

HO Hailey: Okay. Mrs. Wilson you can come in. Before you sit down let me swear you in. You can put your left hand on the Bible, raise you right. Do you solemnly swear or affirm that any testimony you provide today will

be the truth, the whole truth and nothing but the truth?

Stacey Marie Wilson: Yes I do.

HO Hailey: Okay. Would you state your name for the record please?

Stacey Marie Wilson: Stacey Wilson.

HO Hailey: Okay. And Mr. Wilson you have, you can ask your wife questions.

She's your witness.

Robbie Dale Wilson: Okay. In the last six years have I been drinking at all?

Stacey Marie Wilson: No.

Robbie Dale Wilson: And uh on the dates in question we have one that was a .06. Have you ever known that machine to read a .06 without me having a reason for it

to be high?

Stacey Marie Wilson: No, it's usually diabetic reason. Sugar usually high. I know it's been

proven by doctors.

Robbie Dale Wilson: And um is this machine accurate at all?

Stacey Marie Wilson: No, we've had problems with ??? the whole thing coming in.

Robbie Dale Wilson: And do you remember the Monitech technicians stating that the

machine was not very accurate?

Stacey Marie Wilson: Says they have been known to miss some of them and he even agreed

that high that high blood pressure, high blood sugar can cause readings

not be accurate.

Robbie Dale Wilson: False readings. And the technician did not give me a letter because he

worked for the company.

Stacey Marie Wilson: Uh huh. I mean yeah.

Robbie Dale Wilson: And this is their job.

Stacey Marie Wilson: Yeah. (mumbling)

Robbie Dale Wilson: And you've been with me on a number of occasions correct where the

machine has actually locked us out...

Stacey Marie Wilson: Oh yeah.

Robbie Dale Wilson: ...and sat on the side of the road.
